

## PALMCOP, Ready for Action!

PALMCOP (Palmetto Archives, Libraries, and Museums Council on Preservation) is ready for an action-filled year! Just like SCAA, Mother Nature had her fun with archival organizations and their annual meetings this last year. We prevailed and PALMCOP held its annual meeting aptly entitled Fire, Flood, and Mayhem on January 22. Many SCAA members attended and we thank you for your support!

Being prepared and knowing how to handle those unexpected disasters are key factors in protecting and preserving South Carolina's cultural heritage. PALMCOP is sponsoring a one-day Hands-On Disaster Recovery Workshop on June 7 at Clemson University Libraries Depot (offsite facility) starting at 10:00 a.m. Taught by Ann Frellsen, an experienced collections conservator, participants will gain hands-on experience in the salvage of typical library and archives materials. They will also learn the importance of teamwork in managing an emergency response, including safety, public relations, and the recovery of wet materials. A wrap-up session will include time for questions, especially regarding specific collections or situations. Early bird registration before May 20, 2016 is \$80 for PALMCOP members and \$95 for non-members. 

## Spartanburg County Public Libraries Receives NEH Preservation Grant

In December 2015, Spartanburg County Public Libraries was awarded a \$6,000 Preservation Assistance Grant from the National Endowment for the Humanities, to conduct a general preservation needs assessment of its archival collections.

The grant has enabled the hiring of a consultant to conduct a preservation assessment of a large body of materials dealing with the history of the South Carolina upcountry, including items dating as far back as the 1760s. Eva Grizzard, Preservation Specialist at the Northeast Document Conservation Center, visited Spartanburg on May 3<sup>rd</sup>, to conduct an in-depth evaluation of collections, facilities, and staff archival procedures, in preparation for a written report. The final report will a complete assessment and provide guidance and preservation planning recommendations.

The collections include numerous cartographic, architectural, and engineering drawings, much of it related to the textile industry which came to dominate the region. The library also houses large collections photographs and negatives dating from 1884 through the 1990s; business and organizational records; 200 linear feet of manuscripts and correspondence from prominent Spartanburg families, and 300 audiovisual recordings and oral histories, including interviews related to the displacement of a local African American neighborhood through urban renewal. Scholars have used these wide-ranging materials to research a variety of topics including military and church histories and the history of the civil rights movement in Spartanburg County and the Upstate.

## UPRISING OF '34 Documentary Film Retrospective at Spartanburg County Public Libraries

On February 25, 2016, the Spartanburg County Public Libraries hosted a film viewing and panel discussion of the award-winning documentary film, *The Uprising of '34,* first aired in 1995. The film tells the story of the General Textile Strike of 1934, drawing on historic film footage and selections from over 200 hours of oral history interviews.

Following the viewing, co-director Judith Helfand, expert researcher Dr. Janet Irons from Lock Haven University, and archivists/librarians Traci Drummond and Kathryn Michaelis from Georgia State University, led a discussion on the local impact of the strike in Spartanburg County and Upstate South Carolina. Ms. Drummond testified to the importance of these interviews in the context of GSU's Southern Labor Archives and its mission, and Ms. Michaelis demonstrated GSU's new online portal for public access to the complete oral history interviews from the project.

Over 100 people attended, including some community members who remember events at the time of the strike, and others who attested to the positive impact of the film on their communities after its release.

The event was made possible in part by a grant from the National Historical Publications and Records Commission to Georgia State University Library. The grant, in the amount of \$121,418, is enabling GSU's library to digitize and transcribe the recorded interviews. This 18-month project is currently in progress.

Accompanying the program is a six-panel display on the textile industry with a focus on the worker's perspective, featuring

materials from the Spartanburg County Public Libraries' special collections, and an initial online release of "The Textile Industry in Spartanburg County," a growing collection of digitized images available now through SCPL's Historical Digital Collections, at: http://digital.infodepot.org/cdm/

## USC Awards Provost and ASPIRE Grants for Preserving Oral History

Titled "Remembering International Women's Year 1977: An Oral History Preservation Project", Dr. Marjorie Spruill, USC Professor of History and Andrea L'Hommedieu, Oral Historian with the South Caroliniana Library, have received two internal grants: a Provost grant and an ASPIRE grant. The grant work will proceed simultaneously with combined funding of \$35,000 over the next two years.



Dr. Marjorie Spruill, USC Professor of History, and Andrea L'Hommedieu, USC Oral Historian, will begin the grant work in May.

The International Women's Year (IWY) Oral History Collection, spearheaded by the late Dr. Constance Ashton Myers, includes 702 taped interviews of key participants in the 1977 National Women's Conference (NWC), a milestone in the modern history of women and politics in America. Students, historians, and the public will benefit from access to this collection.

The project will preserve, analyze, and publish as an online interpretive database a unique collection of oral history interviews that will illuminate a vitally important but longneglected episode in US history. Currently on cassette tapes, the grant will provide funding to digitize and transcribe up to 350 interviews. Additional funding will be sought to complete the remaining interviews.

## SCAA 2015 Annual Meeting and Fall Conference

"Bridge Builders: Connecting Archives with Your Community," the 2015
SCAA Unconference and fall annual meeting was held at the South
Carolina State Archives in Columbia,
SC on November 17<sup>th</sup>. There were 42 registrants for the Conference.
(SCAA had to reschedule the 2015 conference and annual meeting from its original date of Friday, October 2, 2015 to Tuesday, November 17, 2015 due to statewide weather conditions and flooding.)

The meeting was organized as a series of lightning rounds. Participants had the opportunity to share experiences and highlight ways in which they have connected their archives with diverse user communities and in building networks with fellow archivists.

Two concurrent "Bridge Building" roundtables followed the lightning rounds: one for sharing ideas on outreach, reference and public services, moderated by Mary Jo Fairchild (College of Charleston), and the other on digitization projects, led by Kate Boyd (University of South Carolina), Chris Vinson (Clemson University), and Heather Gilbert (College of Charleston), from the perspective of the South Carolina Digital Library.

Our keynote speakers, archivist Celeste Wiley and Charleston city records manager Meg Moughan, discussed the efforts of Charleston - area archivists, librarians, and museum professionals to organize and preserve the thousands of items sent to and left at Mother Emanuel AME following the tragic killings there on June 17, 2015. Members of the Charleston Archives, Libraries and Museums Council (CALM) are working with historian and archivist Elizabeth Alston at Emanuel AME Church on this ongoing project.
